

**DOOR POLICY NOTIFICATION FORM  
UNDER THE PUBLIC ENTERTAINMENTS AND MEETINGS  
(CLASSIFICATION OF ARTS ENTERTAINMENTS) (EXEMPTION) ORDER 2016**

**Requirements for Exemption from Classification**

Arts entertainment provided by any person holding a valid Category 1 PE Licence is exempted from classification if:

1. The Category 1 PE Licensee has put in place a Door Policy<sup>1</sup> either: (a) during the hours of operation provided for in the Licence, or (b) during a specific period;
2. The Category 1 PE Licensee has notified the Arts Entertainment Licensing Officer of the Door Policy 20 working days ahead of the event; and
3. The content of the arts entertainment being provided does not contain anything that –
  - (a) is likely to undermine national interest;
  - (b) is likely to cause offence to any racial or religious group in Singapore;
  - (c) is likely to cause feelings of enmity, ill-will or hostility between different racial or religious groups in Singapore;
  - (d) is lewd or obscene;
  - (e) promotes any lifestyle or behaviour that is contrary to prevailing social norms, including any alternative lifestyle (such as homosexuality), deviant sexual behaviour or drug use;
  - (f) contravenes any written law.
